### What are some of the department's most satisfying successes of 2024, and why?

The firm's most satisfying successes in 2024 include securing full payment for all unsecured creditors in the Eiger BioPharmaceuticals bankruptcy case, recovering over \$100 million in the E.D. California Ponzi scheme case, and securing a significant \$20 million recovery from Nixon Peabody. Additionally, the firm's representation of victims in the Petters Ponzi scheme resulted in over \$220 million in recoveries. These achievements highlight the firm's ability to handle complex, high-stakes litigation matters and achieve significant results for clients.
